#### **Course Description:**

Considering the current climate, this course will focus on activism and advocacy in the African American (AA) and African diaspora community. Anthropologists, particularly AA anthropologists, have a long history in advocacy work. We are going to trace this work beginning with theory and methods in critical analysis. We will also explore AA and African diaspora contributions to the American way of life and the ongoing battle for recognition, life, liberty, and justice in their communities. The experience of AA and African diaspora populations will be filtered through the lenses of racialization, self-determination, and systemic marginalization. This course will include all the elements necessary for a publishable journal article or conference paper and a final poster presentation.

#### **Learning Objectives:**

Upon successful completion of this course, learners will be able to:

- 1. Apply anthropological theories and critical race theory to political, social, and economic problems in African diaspora and African American (AA) communities.
- 2. Identify the role anthropologists played in racializing AA and the role race plays in anthropology today.
- 3. Articulate how anthropologists contributed and continue to contribute to social movements, and how their continued activism highlights AA resilience and struggle to maintain harmony in their communities.
- 4. Critically analyze social movements and advocacy groups (Civil Rights Movement, Black Panther Party, Black Lives Matter, etc.) including their purpose and impact on AA and African diaspora communities.
- 5. Describe key figures in social movements impacting AA and African diaspora communities, including Frederick Douglass, W.E.B. DuBois, Booker T. Washington, George Washington Carver, Marcus Garvey Jr., Dr. Martin Luther King Jr., Malcolm X, Cornel West, Alicia Garva, Opal Tometi, Patrisse Cullors, etc.
- 6. Critique material that shows the marginalization, disenfranchisement, and/or discrimination of members in the AA or African Diaspora community.
- 7. Create a finals project that analyzes or evaluates an aspect of African Diaspora populations.

#### **Course Texts:**

All course readings will be uploaded to Canvas for your convenience. There is no primary text for this class. However, a bibliography of books, chapters, and articles used in this course is provided at the end of this syllabus. These readings

are subject to change. Changes to assigned readings will be made at least one week in advance. These changes will also be announced in class and posted to Canvas.

#### **Course Prerequisite:**

There are no required prerequisites for this course. However, in order to be successful in this course you will need to:

- Follow instructions on assignment rubrics.
- Cite sources, giving credit to where you obtain information.
- Communicate with others through discussions and utilize tact when offered differing perspectives.
- Make the commitment to spend at least five hours a week reading the assignments, reflecting on the material covered, and participating in other activities throughout the course.

#### **Course Structure:**

The first session will be an introduction to the course syllabus, student expectations, and teacher expectations. You will also have a discussion question to get you thinking about race and power. In all future sessions, I will typically provide a lecture covering the topic of the day during the first 60 minutes of class. Students are encouraged to ask questions and provide input during lectures. Twenty minutes will be allotted for in-class discussions of the lecture and assigned readings. The last 90 minutes of the session will be treated as an opportunity for group work. You will work with your group on your publication and final project in class every Wednesday. I will also work with you all in class to make sure everyone is on the same page. All lectures will be recorded on Zoom and posted within 24 hours on Canvas.

#### **Course Website:**

All course materials, readings, and other resources necessary for this course will be available on Canvas. All assignments must be submitted through Canvas. All questions and correspondence must be submitted to my UNT e-mail directly or through Canvas. Please use your UNT e-mail ONLY to correspond with me.

#### **Evaluation:**

There will be many opportunities for you to sharpen your critical thinking skills in this class. Your assignments and final project will all require critical thinking. All work must be completed using Microsoft Word, 12-point font, double-spaced, 1-inch margins (top, bottom, right, and left).

# Class Participation: (15% of total grade)

As there are only 15 days that we meet this semester. Each day (in-person or Zoom) is worth 10 points. You will need to participate in classroom discussions by posting on Zoom or commenting in class. Please communicate with me if you are having trouble attending class. I cannot accommodate you if you do not communicate with me.

# Abstracts: (8% of total grade; due by 11:59PM on Thursdays)

You will submit your abstract as a group twice for a total of 80 points. An abstract is a short synopsis or your work and your findings. The first draft is always incomplete. Hence, you will submit your abstract twice. Your abstract must be between 150 and 200 words. Use the Abstract Rubric for guidance. I will not take off points if you go over on the first draft. You will be able to submit your abstract three times as a group. Your last draft must meet the word requirement. I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

# Introductions (10% of total grade; due by 11:59PM on Thursdays)

In your introduction, you will provide a problem statement, outline the current research, discuss your contribution to the research, state your question(s) and hypotheses, and provide a road map for your study. We will go over each one of these section in class and I will provide several examples for you all to follow. **You may submit your introduction three times as a group. Use the Introduction Rubric for guidance.** I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

#### Literature Reviews (15% of total grade; due by 11:59PM on Thursdays)

Literature reviews allow you to critically evaluate the work of those who came before you. This is your opportunity to inform yourself and locate any gaps in the research. This is where you demonstrate that you understand what others have said before you. **You may submit your literature reviews three times as a group. Use the Literature Review Rubric for guidance.** I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

## Materials (5% of total grade; due by 11:59PM on Thursdays)

In the materials sections, you will discuss what data you will use in your project. This data needs to be readily available. I will help you all find data for your projects. You will need to discuss why you chose these data and how they relate to your questions or research problem. **You may submit your materials section three times as a group. Use the Materials Rubric for guidance.** I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

#### Methods (10% of total grade; due by 11:59PM on Thursdays)

In the methods section, you will discuss how your data will be gathered and what types of data will be gathered. You may submit your methods section three times as a group. Use the Methods Rubric for guidance. I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

#### Results/Findings (10% of total grade; due by 11:59PM on Thursdays)

The results section is simply for results. You will layout your significant findings. No findings are findings. Also, all findings will tell you something about the problem you are researching. **You may submit your results three times as a group. Use the Results Rubric for guidance.** I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

## Discussions (10% of total grade; due by 11:59PM on Thursdays)

The discussion section is the space where you discuss your results or findings. This is where you tell the reader what your results mean. This is also where you discuss whether or not your questions where answered and/or your hypothesis confirmed or falsified. **You may submit your discussion three times as a group. Use the Discussion Rubric for guidance.** I will address each group independently regarding any comments I have concerning you all's work. All assignments are due on Thursdays at 11:59pm.

#### Conclusions (5% of total grade; due by 11:59PM on Thursdays)

It is in the conclusion that we summarize our findings and discuss future endeavors. It is also in this space that we critique our own work. What could you have done differently? What worked? What didn't work?

#### Core Assessment (2% of total grade, due by 11:59PM on Thursday)

These are mandatory core assessment questions that assess communication, social responsibility, critical thinking, and personal responsibility. They are worth 20 points.

#### Final Project Poster Presentations: (10% of total grade; due by 11:59 PM on Thursday)

The final project presentation is worth 100 points. You will present your work during the last week of classes in a poster format. Refer to the **Final Project Poster Rubric for more details**.

Please take these assignments seriously as they make up a sizable portion of your total grade. All assignments are due on Thursdays. I will not accept late assignments without prior notification or a legitimate excuse.

#### Important Notice for F-1 Students taking Distance Education Courses

#### Federal Regulation:

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

## University of North Texas Compliance:

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an oncampus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

#### Transmission and Recording of Student Images in Electronically-Delivered Courses

- 1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
